-Hook and Ladder Station 1 – 21 March 2023

The regular monthly meeting of the Lebanon County Firefighter's Association was called to order at 19:30 hours with President Lee Spencer presiding. The Pledge of Allegiance was followed by the singing of the first verse of America. The Invocation was offered by Ron Miller. President Spencer appointed Bill Kale and Mark Kissinger as Sergeants at Arms. The Address of Welcome was provided by host Randy Lebo and the Response offered by Steve Yeagley

A moment of silence was held in honor of the passing of Carl Kreiner and Samuel Spitler.

A roll call of officers and delegates was held, followed by the reading of the minutes from the previous meeting which were approved as read.

Officer's Reports

- President Spencer:
 - Reported that the Association was approved for a \$25,000 grant from South Lebanon from the Casino funds. The funds were to be allowed for the pavilion project; these funds will now be put towards the purchase of the dumpster for vehicle/dumpster fires.
- Vice Presidents:

- Recording Secretary Marks: Reported no luck on response to a message for Duane Troutman and not much assistance from the Historical Society on the previous minutes.
- Financial Secretary: Simmon Reported 68 Beneficial members, 28 non-Beneficial members, 254 Life members, 367 total members. 7 new members and 56 non-payment members. 4 deaths reported between June 2022 to May 2023. Death Liability is \$64,400

Motion seconded by Barry Batz, Motion carried.
