A moment of silence was offered in remembrance of Association member Leon Boyer, Neptune Richland

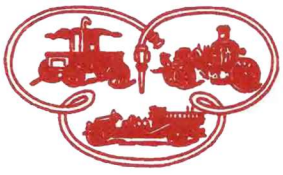

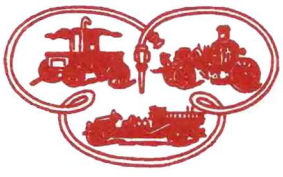
